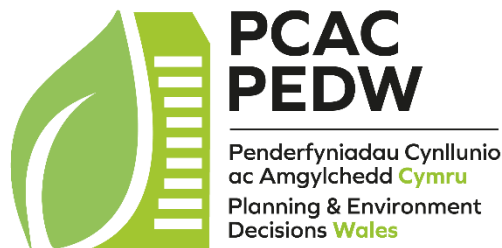

### **ATISN 20339 – Request for information**

Thank you for your request which was received on 12 March 2024. You asked for the following information, in relation to the proposed Solar Panel array at Craig y Perchyll Farm in north Swansea:

1. How many responses have you received during the entire Consultation period for the above named Solar Panel array?
2. Is it possible to have lists of (a) supporters; (b) objectors and (c) neutrals, for the above named Solar Panel array? Just a list - not the details, of what they have submitted.
3. Is there a listed summary on your website, if so, can I have a copy of the link?

### **Our Response**

I will address the three aspects of your request in order:

1. PEDW received 210 responses during the representations period for this application.
