#### Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4042 (Cylchfan Caerllion, Casnewydd i Gylchfan Cwmbrân, Torfaen) (Gwahardd Cerbydau Dros Dro) 2024 a daw'r Gorchymyn hwn i rym ar 7 Mawrth 2024.

#### Dehongli

2. Yn y Gorchymyn hwn—

### ROAD TRAFFIC, WALES

The A4042 Trunk Road (Caerleon Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2024

Made

1 March 2024

Coming into force

7 March 2024

The Welsh Ministers, as traffic authority for the relevant length of the A4042 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

#### Title and commencement

1. The title of this Order is the A4042 Trunk Road (Caerleon Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2024 and this Order comes into force on 7 March 2024.

#### Interpretation

2. In this Order—

“exempted vehicle” (“cerbyd esempt”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 20:00 o’r gloch ar 7 Mawrth 2024 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith yn barhaol; ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A4042 Casnewydd i Amwythig.

## Gwaharddiad

**3.** Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darnau o’r gefnffordd a bennir yn yr Atodlen i’r Gorchymyn hwn.

## Cymhwysyo

**4.** Nid yw’r gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y’i dangosir gan arwyddion traffig.

## Cyfnod para’r Gorchymyn hwn

**5.** Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“the trunk road” (“*y gefnffordd*”) means the A4042 Newport to Shrewsbury trunk road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 7 March 2024 and ending when the temporary traffic signs for each period of works are permanently removed.

## Prohibition

**3.** No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in the Schedule to this Order.

## Application

**4.** The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

## Duration of this Order

**5.** The maximum duration of this Order is 18 months.

The length of the eastbound carriageway of the trunk road that extends from its junction with the eastern side of Grove Park Roundabout to its junction with the western side of Caerleon Roundabout, Newport.

The length of the trunk road that extends from its junction with the northern side of Grove Park Roundabout, Newport to its junction with the southern side of Croes-y-Mwyalch Roundabout, Torfaen.
