

**GORCHYMYN CEFNFFORDD YR A487 (MAN  
I'R DE O ABERAERON, CEREDIGION)  
(GWAHARDD CERBYDAU DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A487, neu gerllaw iddi, i'r de o Aberaeron, Ceredigion.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd rhag mynd ar y darn o gefnffordd yr A487 sy'n ymestyn o'i chyffordd â Phanteg i'w chyffordd â mynedfa Maes Carafannau Wide Horizons.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de yw mynd ar yr A482 tua'r de-ddwyrain Heol Llyswen i Lanbedr Pont Steffan, yr A475 tua'r de-orllewin drwy Lanwnnen i Horeb a'r A486 tua'r gogledd i ailymuno â'r A487 tua'r gogledd/tua'r de yn Synod Inn: i'r gwrthwyneb ar gyfer traffig sy'n teithio tua'r gogledd.

Daw'r Gorchymyn i rym ar 14 Mawrth 2024. Disgwylir y bydd y gwaharddiad dros dro yn weithredol yn ysbeidiol dros nos (19:00 o'r gloch tan 06:00 o'r gloch) o 14 Mawrth hyd 29 Mawrth 2024, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A487 TRUNK ROAD (SOUTH OF  
ABERAERON, CEREDIGION) (TEMPORARY  
PROHIBITION OF VEHICLES) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A487 trunk road south of Aberaeron, Ceredigion.

The effect of the Order is to temporarily prohibit all vehicles from proceeding on the length of the A487 trunk road that extends from its junction with Panteg Road to its junction with the entrance to Wide Horizons Caravan Park.

The alternative route for southbound vehicles is via the south-eastbound A482 Lampeter Road to Lampeter, south-westbound A475 through Llanwnnen to Horeb and northbound A486 to rejoin the north/southbound A487 at Synod Inn: vice versa for northbound traffic.

The Order comes into force on 14 March 2024. The temporary prohibition is expected to operate intermittently overnight (19:00 – 06:00 hours) from 14 – 29 March 2024, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
