Meeting summary

Yesterday I met with [REDACTED – PERSONAL INFORMATION Qatar businessperson] who is heading up [REDACTED – COMMERCIAL INFORMATION Qatar company] interest in capital investment opportunities in the UK.

He explained that they are keen to acquire Grade A Office space and that Cardiff is on their radar. He also added that he was hoping to visit Cardiff in October, possibly with his VP colleague(s). Before I provide an introduction by separate email I thought it would be useful to summarise our key discussion points:

- [REDACTED COMMERCIAL INFORMATION Qatar company] recently bought an investment in Bristol, a Cardiff opportunity had been a contender but was deemed too expensive at the time
- Since 2015 Gulf/ Middle East investors including Qatar, Kuwait, KSA and UAE have been looking to expand their portfolios outside of London
- Qatar (and other major capital investors) have been keen to test the capital investment
  waters but there is limited stock on the market at present as vendors believe they will get a
  better deal post Brexit
- Traditionally few vendors pulled out of negotiated deals but increasingly the case, this
  happened to [REDACTED COMMERCIAL INFORMATION Qatar company] in Newcastle
  recently
- [REDACTED COMMERCIAL INFORMATION Qatar company] are looking for Grade A Office space with a single tenant, they are not interested in retail
- Any investments would be managed by a Property Manager
- Some due diligence is done in the [REDACTED COMMERCIAL INFORMATION Qatar company] London offices (no. 2) but is increasing being brought in-house to Qatar, which [REDACTED PERSONAL INFORMATION Qatar businessperson] will lead on
