Deprivation Indicators within the Settlement Formula

Summary

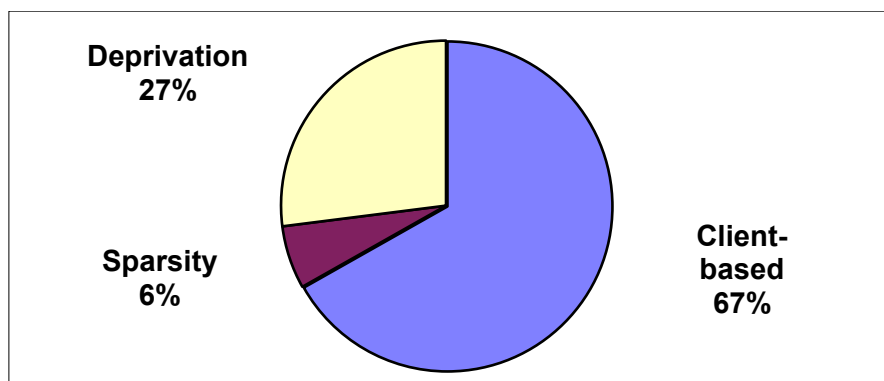
1. This paper summarises the current situation regarding deprivation indicators within the Settlement; identifying the source of the indicator and the date last updated.

Views sought:

2. **None** – this paper is for information only.

Section 1: Background and Current Situation

3. The formula for calculating the Local Government Revenue Settlement contains indicators of **deprivation** that are designed to reflect the additional cost of providing services to populations with higher levels of deprivation, e.g. income support recipients, people with long-term illness etc.
4. In 2023-24, 27% of the total SSA was attributed to deprivation indicators, with 67% based on client-based indicators and the remaining 6% on Sparsity indicators:



5. A breakdown of the 2023-24 per capita SSA, by Indicator Type and Unitary Authority is shown in Table 1 in Annex A.
6. Currently, the Settlement includes 20 indicators that measure deprivation (see **Table 2 in Annex A** for full list). These indicators were designed and developed by Pion Economics.

7. **Table 2** also shows the total 2023-24 SSA share relating to each deprivation indicator – ranging from 0.1% for **Adults aged 18 to 64 in non-white ethnic groups** to 7.3% for **Dependent children in out of work families**.
8. **Table 3** in **Annex A** illustrates which formula-based IBAs use the deprivation indicators and, for each of these IBAs, how much SSA is distributed on each indicator within each IBA (based on the 2023-24 Settlement).
9. The amount of SSA distributed on the deprivation indicators is around £1.994 billion (27% of the total SSA), almost £1.6 billion of which is distributed within *Personal and Social Services* (PSS) sector IBA (which equates to 21% of the total SSA).

Data Sources

10. Some of these indicators are census-based whilst others are updated annually. There are also a small number of indicators that are currently frozen due to the roll-out of Universal Credit.

Census-based indicators

11. At present, the following 9 deprivation indicators used in the Settlement are based on the 2001 Census:
 - Dependent children in households where head is in a low occupational classification;
 - Dependent children in lone adult households;
 - Dependent children in social rented housing;
 - Dependent children in overcrowded housing;
 - Pensioners living alone in households;
 - Pensioners with a limiting long-term illness;
 - Households where head is aged 18 to 64 with no carer;
 - Adults aged 18 to 64 in non-white ethnic groups; and
 - Population aged under 18 in wards with weighted density greater than the Welsh average.
12. These census data indicators currently account for 11.4% of the total SSA distribution and mainly impact the distribution of the PSS Sector IBA.
13. The relevant data from the 2021 census is now available. However, in previous DSG meetings (in discussion about inclusion of the 2011 census indicators) it was determined that in-depth multi-level analysis should be undertaken to properly investigate the drivers of need within each IBA containing census data.
14. The group recognised this would require a large amount of resource and this should be considered in the context of wider priorities for the DSG going forward.

Other data sources:

15. The following 7 deprivation indicators have various sources and are updated annually. Combined, these currently account for 5.8% of the total SSA:
 - Income support, job seekers allowance, pension credit or universal credit (not in employment) claimants, aged 18-64;

- Index-weighted working age population;
 - Pension credit claimants aged 65 and over;
 - Secondary pupils eligible for free school meals;
 - Primary pupils eligible for free school meals;
 - Severe disablement allowance or disability living allowance claimants or personal independent payments, aged 18-64; and
 - Total income support, job seekers allowance, pension credit or universal credit (not in employment) claimants.
16. Those deprivation indicators that relate to **Benefit claimants** i.e. Income Support, JSA, Pension Credit, Universal Credit (not in employment) and disability related benefits (PIP, SDA, DLA) are currently used to distribute 4.2% of the total SSA.
17. The 2023 DSG Workplan recognises that benefits related data are key components of the Settlement, with continued need for DSG to monitor the emerging impact of welfare reform on the data used in the formula.
18. This approach will also apply to the treatment of the '*Dependent children in out of work families*' and '*Housing Benefit Recipients*' indicators which are currently **fixed** due the roll out of Universal Credit. These 2 indicators are currently used to distribute 6.5% of the total SSA.
19. The '*Dependent children in out of work families*' dataset carries 68.5% of the weighting towards the 'Children and young persons' IBA. It is also the deprivation indicator that distributes the largest share of the total SSA (7.3%). As Universal Credit was having a negative distributional effect on this dataset, DSG agreed to freeze it for the 2019-20 settlement onwards using the 2016-17 data.
20. The *Homelessness* indicator is also frozen – this currently distributes 0.3% of the total SSA. For the 2016-17 settlement onwards DSG decided to freeze the data using a 3-year average of 2012-13 to 2014-15. This was because the data was no longer published and different datasets would be investigated.
21. The Non HRA Housing service IBA uses both the total homelessness decisions (31.3% weighting) and housing benefits recipients (16.3% weighting) datasets.

Table 1: SSA Per Capita, by Indicator Type and Unitary Authority, 2023-24

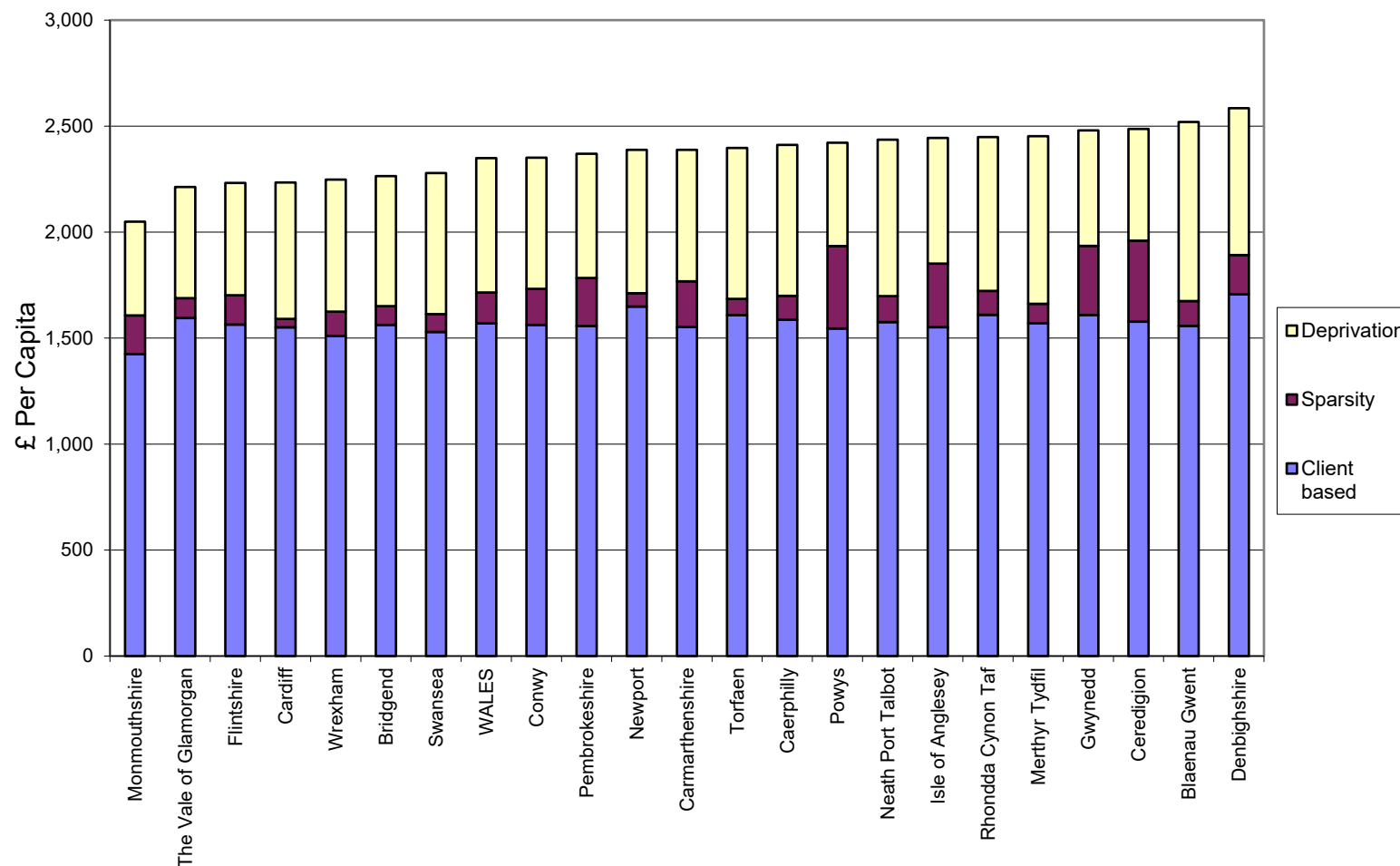
