ATISN 19449 – PIP Assessment and Neurodiversity

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 06 April 2024 regarding Personal Independence Payment (PIP) and Neurodiversity. You have requested the following:

1. *How many PIP applications that are not related to mobility are rejected vs those that are related to mobility*
2. *How many rejected applications for mobility and non-mobility are then granted after the first review?*
3. *How many applications for mobility and non-mobility are only granted after tribunal?*
4. *How many people with neurodivergent conditions are successful in PIP applications at the different stages i.e: first review, second review and tribunal.*
5. *What training is provided to all PIP assessors to correctly assess neurodivergent conditions such as ADHD and Autism?*
 - a. *For people that are successful in their PIP application with neurodivergent conditions, did they always have a formal diagnosis despite any other evidence submitted.*

Response

Welsh Government does not hold information relating Personal Independence Payments as this is not devolved to Wales and is a Department for Works and Pensions benefit.
