## **ATISN 19464 – Gender Identity Services**

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 11 April 2024. You have requested the following:

- *the number of children in Wales on the waiting list for gender identity services.*

### **Our Response**

From information provided by the NHS Wales Joint Commissioning Committee, Welsh Government are aware that as of 18 March 2024, 255 young people are on the waiting list for gender identity services.

These services are commissioned from NHS England by the NHS Wales Joint Commissioning Committee (previously known as Welsh Health Specialised Services Committee) and they may hold more up to date information. ### **Next Steps**

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection.
