

## **ATISN 20310 – Wind Energy Public Consultation**

Thank you for your request which was received on 11<sup>th</sup> March 2024. You asked for:

Full details of the public consultation process undertaken by Welsh Government - and your environmental consultants Arup - regarding proposed developments within the 10 pre-assessed areas in Wales. Including:

- 1) the community and town councils consulted,
- 2) the location and dates of public meetings arranged to explain proposals to the public,
- 3) the notices published in local newspapers to inform the public of the meetings,
- 4) and what records of the public meetings are held by Welsh Government.

### **Our response**

Our response to the information you requested is: -

In relation to research conducted by Arup to inform the development of renewable energy policy and Pre-Assessed Areas in Future Wales.

1) One Voice Wales (see note of information below) was invited to an Arup workshop at Park Plaza Cardiff on 12<sup>th</sup> December 2018 to gather views about potential approaches to research. Outcomes from the workshops are integrated into Arup's '*Assessment of onshore wind and solar energy potential in Wales*' Phase 1 report.

### **Note of information**

The Arup research, '*Assessment of onshore wind and solar energy potential in Wales*', was a technical report to provide evidence to help inform the subsequent development of Future Wales renewable energy policy. Arup consulted specific stakeholders including those with specialist knowledge to support this research. Outcomes of stakeholder engagement are integrated into the [Phase 1 and Phase 2 reports](#), which are publicly available on the Welsh Government website.

The research did not prepare policy or identify any specific renewable energy developments, it did put forward possible policy options and conducted a constraints exercise and landscape evaluation aimed at identifying areas that may be suitable for wind and solar energy development in Wales. The assessment methodology is set out in the Phase 1 and Phase 2 reports.

Wider engagement and consultation with the public and other interested parties, including town and community councils, took place as policies (on all planning topics) were being developed by the Welsh Government during the preparation of the NDF/Future Wales. The development of Future Wales policies 17 and 18, which provide a policy framework to

assess large scale renewable energy proposals, were part of the extensive overall consultation and engagement process.

Individual responses to the Draft National Development Framework (2019), including Town and Community Councils comments about renewable energy and priority area policies (prior to them becoming Pre-Assessed Areas), can be viewed at the link below.

One Voice Wales represents all Town and Community Councils across Wales. They provided the Welsh Government with contact details to receive newsletters about the NDF/Future Wales's progress. One Voice Wales had responsibility for disseminating the newsletters to members. Approximately 17 newsletters about Future Wales progress were sent out between 2017 and February 2021 (when Future Wales was published). National Development Framework for Wales - Newsletter 007 - September 2018 notified newsletter subscribers that Arup had been commissioned to undertake research into onshore wind and solar energy.
