

DEDDF CYNLLUNIO GWLAD A THREF 1990

GORCHYMYN CAU PRIFFYRDD (TIR SY'N CWMPASU LONGMEADOW COURT, CASNEWYDD) 2024

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 (“Deddf 1990”) i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. 
a. nad yw o fewn pwerau Deddf 1990; neu

TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (LAND ENCOMPASSING LONGMEADOW COURT, NEWPORT) ORDER 2024

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 (“the 1990 Act”) to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The Welsh Ministers are satisfied that the stopping up is necessary, and it will be authorised only in order to enable a development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by Newport City Council on 2 October 2023 with reference 21/1068 and described in Schedule 2 to this Order.

The Stopping Up of Highways (Land encompassing Longmeadow Court, Newport) Order 2024 (“the Order”) ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal office hours at Ringland Library and Information Centre, Ringland Centre, Ringland, NP19 9PS, or may be obtained free of charge from the address below quoting reference qA2000704.

If a person is aggrieved by the Order, on the grounds that:

a. it is not within the powers of the 1990 Act; or

b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 16 April 2024 make an application for the purpose to the High Court.

Demolition of existing vacant properties, proposed residential development of 35 units and associated works.
