# Request for Information – ATISN 23221

Thank you for your Freedom of Information Request to the Welsh Government on the 31 December 2024.

### Your request

You asked for information regarding the Welsh Government's relationship with Aerodyne and asked the following questions:

- 1) How much money did the Welsh Government spend on preparatory work or site alterations for Aerodyne's occupancy of the Bro Tathan business park?
- 2) What was the nature of the preparatory work / alterations paid for by the Welsh Government?
- 3) Did Aerodyne pay for any preparatory work / alterations to the site, and if so, what amount did it pay?
- 4) When did the lease begin and when did it end?
- 5) How much in rent did the Welsh Government receive from Aerodyne?
- 6) How much did the Welsh Government receive from Aerodyne in payment other than rent, and for any such payment please state the reason for the payment.
- 7) Is Aerodyne in debt to the Welsh Government, and if so, what is the amount owed, what was the debt in relation to, and when was it due to be paid?
- 8) Welsh Government civil servants spent time assisting with recruitment for Aerodyne, including helping facilitate the hiring of Aerodyne's former CEO Valerie Ellis, who was first contacted about the role by a civil servant. How many hours did Welsh Government civil servants spend assisting recruitment for Aerodyne?
- 9) What was the cost of those hours of work?
- 10) How many hours in total did Welsh Government civil servant spend on work on behalf of Aerodyne?
- 11) What was the nature and cost of those hours of work?

#### Our response

I can confirm that we hold some of the information you have requested. Using your numbering our response is next to your queries:

- 1) The Welsh Government did not spend any money on the property prior to Aerodyne's occupancy
- 2) Not applicable
- 3) Aerodyne did undertake some works to the premises we do not hold information on the cost of those works.4) The lease commenced on 1<sup>st</sup> September 2023 and ended on 16<sup>th</sup> December 2024.
- 5) The Welsh Government has not received any rent from Aerodyne
- 6) Other payments due under the lease were service charge and insurance premium.
- 7) Aerodyne has accrued arrears of £9,269.86 relating to payments due under the lease. A rent deposit of £8,750 is held and will cover the majority of these arrears.

- 8) No support was provided with recruitment from Welsh Government.

#### **Personal information**
