All bird keepers must register their birds (excluding those psittacines (parrots, cockatoos and budgerigars) and passerines (small 'perching' birds, such as finches, sparrows, tits, wrens and jays) that are permanently housed either within a dwelling, or within a bird house on the same premises with no access to outdoors) – this is a legal requirement.
