### **Your Request**

You asked for the following information:

- The audited costs for changing 30 mph to 20 mph.
- The audited costs of changing from 20 mph to 30 mph since Sept 2024.

I can confirm that the Welsh Government holds the information you have requested. The table below indicates the monies claimed and paid to each authority, exception being Financial Year 2024 – 25, which is the awarded amount.
