Thank you for your email with the written confirmation of the Notification Event. Before we look to withdraw the funding completely, we were looking at your application and wondered if there was still an option for you to deliver some of the project elements as highlighted below:

The project will;

i) formalise the car park allocation in the Village Green area (which is at capacity and being abused with deteriorating conditions).

ii) introduce an accessible parking zone with disabled parking bays with direct access to the coast and beach.

iii) install a sustainable drainage system to provide destination with a quality all year round parking offer

iv) Purchase and supply of new bins to improve recycling and reduce litter with bins utilising the "Internet of Things" technology which monitors, via a sensor, how full they are and then links to our Operational Team via a dashboard.

v) Installation of new and up to date signage including promotional visitor information, car park usage including those for Motorhomes as well as water safety signage.

If you did decide to progress with any of these elements, we would need you to send us a breakdown of the costs for us to could consider and if approved we could send you a variation letter.

However, these must be delivered and all spend incurred and claimed by 31st March.

Thank you for your email and patience in dealing with Llansteffan. I will answer each of your pints in turn below.


- If you could address the variation letter to me please.
- The toilet block works are not being carried out by the same contractor and was not on the programme, The refurbishment works are relatively minor and are more maintenance related and will not take that long.
- The charging infrastructure installation, smart bins and signage will be provided by our appointed contractor and are generalised within the car park works on their programme. Would you like me to get them to append their programme to include these specific items.
- The lease agreement is due to be signed in January, I do not have as specific date for this now.
- The cost estimate does not add up as you correctly state, this was down to me having rounded estimates for the remaining works and the cost to date figure being a specific cost. We are still working to the same total figure of £280,000 which is made up of £224,000 of grant funding and £56,000 of match funding. Our costs to date have now increase slightly and I have changed the table to add up to the correct values.

The reduction in car park works has been mitigated by an increase in cost for the flood defence proposals, which will be of great benefit to the area.
