## 1. Please give a summary of the proposed change, the reasoning behind it and the impact it will have on the project.

Due to legal issues with charging for parking on land designated as village green and the Community council not leasing their Land to Carmarthenshire County Council. The requirement for providing charging is removed from the scheme together with overflow parking. It is proposed that funding is used to carry out maintenance works in the current parking areas in the North Car park and carry out the original planned proposal in the area of the North car Park owned by Carmarthenshire County Council. It is also planned to provide greater accessibility and provision in the existing South Car park. In addition, greater flood defence assets will be provided to provider greater resilience and ensure all year tourism access is maintained.

- Restore the condition on the surface running area to the North Car Park including access.
- Provide improved surface areas within Carmarthenshire County Council land in North Car Park/Village green to allow greater community use and greater disabled parking,
- Repair flood bunds to ensure all year tourism access is maintained,
- Provide flood defence assets to have greater resilience to defend flooding incidents to ensure all year tourism access is maintained.
- Provide DDA compliant access to Coastal path and improved beach access.
- Provide DDA compliant access to play areas from South Car Park
- Rationalise parking improvements in South Car Park
- Install charging infrastructure in South Car Park
- Renovations to existing toilet block.
- Improve service areas to businesses.
- Provide drainage systems to ensure quality all year-round usage.
- Purchase and supply of new bins to improve recycling and reduce litter with bins utilising the "Internet of Things" technology which monitors, via a sensor, how full they are and then links to our Operational Team via a dashboard.
- Installation of new and up to date signage including promotional visitor information, car park usage including those for Motorhomes as well as water safety signage
- Introduce an accessible parking zone with disabled parking bays with direct access to the coast and beach.
