### **Request for Information – ATISN 23330**

Thank you for your Freedom of Information Request to the Welsh Government on the 3 February 2025.

### **Your request**

You asked for information regarding the Welsh Government's relationship with Aerodyne and asked the following questions:

How much public money has been spent/invested in any way in relation to Aerodyne?

On how many occasions did Welsh Ministers or Welsh Government officials meet with representatives of Aerodyne?

Has the Welsh Government, or Welsh Government officials, been at all involved in assisting the recruitment process for Aerodyne?

### **Our response**

I can confirm that we hold some of the information you have requested. Using your numbering our response is next to your queries:

- 1) £48.14
- 2) There are 12 recorded meetings between Welsh Government officials and Aerodyne.
- 3) No Welsh Government support was provided with recruitment.

### **Next steps**

Commissioner will not normally investigate a complaint until it has been through our own internal review process.

## **Personal information**

The request you sent me contains personal information about you - for example, your name and email address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.
