**The Directions to Local Health
Boards as to the General Dental
Services Statement of Financial
Entitlements (Amendment) (No.2)
Directions 2025**

Made 30 January 2025

Coming into force 31 January 2025

The Welsh Ministers, in exercise of the powers conferred on them by sections 60, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006⁽¹⁾, after consulting in accordance with section 60(4) of that Act both with the bodies appearing to them to be representing of persons to whose remuneration these Directions relate and with such other persons as they consider to be appropriate, give the following Directions:

Title and commencement

1.—(1) The title of these Directions is the Directions to Local Health Boards as to the General Dental Services Statement of Financial Entitlements (Amendment) (No. 2) Directions 2025.

(2) These Directions come into force on 31 January 2025 but have effect from 1 April 2023⁽²⁾.

**Amendments to the General Dental Services
Statement of Financial Entitlements**

2. The Directions given by Welsh Ministers to Local Health Boards as to the General Dental Services

(1) 2006 c.42.

(2) Section 60(3)(e) of the National Health Service (Wales) Act 2006 permits the retrospective effect of Directions given under s.60 of that Act provided such provision is not detrimental to the persons to whose remuneration it relates.

Statement of Financial Entitlements⁽³⁾, which came into force on 24 April 2009, are amended as follows.

Amendment to section 2

3. In section 2 (negotiated annual contract values), for paragraph 2.8 substitute—

“2.8 The percentage determined by the Welsh Ministers for the financial year commencing on 1 April 2023 is 5%.”.

Amendment to section 7

4. Section 7 (payments in respect of vocational training) is amended as follows—

- (a) in paragraph 7.2(c) (eligibility for payments in respect of vocational training), for “£3,084” substitute “£3,416”;
- (b) in paragraph 7.4(c) (applications for payments under this section), for “£3,084” substitute “£3,416”;
- (c) in paragraph 7.5 (vocational training payments to be made)—
 - (i) in sub-paragraph (a), for “£1,010” substitute “£1,061”;
 - (ii) in sub-paragraph (b), for “£3,084” substitute “£3,416”; and
 - (iii) in sub-paragraph (d), for “£5,928” substitute “£6,281”.
