We are contacting external stakeholders to obtain comments on Candidate Sites submitted for consideration for inclusion in the Monmouthshire RLDP. Stage 3B of our Candidate Site assessment methodology involves consultation with external statutory agencies. There are approximately 112 Candidate Sites that have reached Stage 3A and remain in the process. Of these sites 42 are located either within/immediately adjacent a Registered Historic Park and Garden, or, are in close proximity to a Scheduled Ancient Monument.

We would be grateful if you could provide comments on the 42 sites listed in the attached excel spreadsheet and return to us by 28th April if possible. I have also attached GIS files that show all of the sites that have reached Stage 3A, this can be used to see site boundaries (please note this is the whole layer so you will need to cross check with the spreadsheet to locate the 42 sites). If you are unable to use these files plans are included in the Candidate Sites Register which is available on the Councils website [Monmouthshire Replacement Local Development Plan Candidate Sites Register - Monmouthshire](#). If you require any further information please let us know.
