Dear Safeguarding and Advocacy Team,

We asked our safeguarding teams to provide us with the numbers of children (quarterly) who have been subject to CSE strategy discussions over the last two years so that we can understand whether the numbers appear to increase. The data did not suggest an increase in trends. Although, as we explained below, the query about whether the child has been the victim of gang-based or organised network-based abuse is not readily identifiable from this data, as we understand it. However, Gwent Police tell us anecdotally that the numbers have not increased recently.

In answer to your other question below, our multi-agency partners have the following approaches, processes or tools available to them in order to support the identification of and response to CSE within the Gwent region:

- Routine Multi-Agency Child Exploitation (MACE) meetings (quarterly reported into Gwent Safeguarding Board)
- Application of the Child Exploitation Measurement Toolkit (CEMT)
- Safer Schools Engagement processes
- Weekly multi-agency Missing Children meetings
- Multi-agency safeguarding hubs including Safeguarding Hub Delivery Groups (which report into Gwent Safeguarding Board).
- Missing Children's Steering Group (reported into Gwent Safeguarding Board)
- Exploitation team (formerly Operation Quartz) for higher risk children.
- National Referral Mechanism (NRM) across all 5 L.A.s to promote local decision-making about children who are victims of modern slavery in a way which complements existing safeguarding structures.

We hope this is helpful.
