**THE A40 TRUNK ROAD (WHITLAND WEST &
EAST ROUNDABOUTS, CARMARTHENSHIRE)
(DERESTRICTION) ORDER 202-**

The Welsh Ministers propose to make an Order in exercise of their powers under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to derestrict to the national speed limit the lengths of the A40 trunk road specified in the schedule to this Notice.

During a period of 21 days from 9 Ebril 2025, a copy of the proposed Order, plan and Statement of Reasons for making the Order may be inspected, free of charge, during normal opening hours at Narberth Library - 3 Town Moor Mews, Narberth, SA67 7DF. These documents can also be viewed on the Welsh Government's website at <https://gov.wales/road-orders>.

Objections, specifying the grounds on which they are made and quoting reference number qA2268109, must be sent by e-mail to TransportordersBranch@gov.wales or in writing to the address below by 30 April 2025.

Should you wish to object, support or make representations, the Welsh Government may need to consult with people and organisations outside the Welsh Government. As part of the consultation process we may pass information to them, including information you have provided and your personal data. We will, however, only disclose your personal details where it is necessary to do so to address the issues raised. If you do not wish for your personal data to be forwarded to third parties, you should state this when submitting your correspondence. The Welsh Ministers will copy the representations to the appropriate third parties with the name and address removed and if there is to be a local Public Inquiry, the representations will be seen by the Inspector who may give them less weight as a result.

SCHEDULE

The length of the A40 trunk road that extends from a point 64 metres west of its junction with Whitland West roundabout to a point 74 metres north-east of the said roundabout including its circulatory carriageway.

The length of the A40 trunk road that extends from a point 34 metres west of its junction with Whitland East roundabout to a point 45 metres east of the said roundabout including its circulatory carriageway.
