Thank you for your email and notification of the call-in request.

The application remains to be under consideration as I am awaiting responses from our internal ecology colleagues. Once received I will be in a position to progress towards a determination. For an application to be referred to Planning Committee, the LPA needs to have received 3 or more objections from local residents from separate households, or a request received from the Local Member for the application to be determined by the Planning Committee, or a request from the Head of Place and Sustainability that the application be considered by the Planning Committee. At present, none of these criteria have been met, in fact the LPA has not received any objections or correspondence from third parties. Therefore, the application is to be determined under delegated powers.

For clarity and to add to the public file, can you therefore confirm that the LPA is unable to issue a decision granting planning permission until you have confirmed whether or not the application is to be called in.
