Regarding the Welsh tab not appearing, I'd like to understand this a bit better so we can get to the bottom of it. Could you let me know how you were accessing the website when this happened – for example, what device and browser you were using? That would really help us identify what might be causing the issue, as it seems to be displaying correctly for others.

In terms of the Welsh Language Policy, I believe ***** is currently in the process of reviewing and updating it. I understand she's arranging to meet with the Welsh

Language Commissioner as part of this, but I'll double-check the timeline and confirm when that's likely to happen.
