### Information requested

Thank you for your request which I received on 13 July 2025. You have requested information under the Freedom of Information Act regarding the Hwb Programme. Specifically, you have asked for details on the following:

- 1. A detailed breakdown of the current staffing structure of the Hwb programme (or Digital services division), including:
  - 1.1. All individual roles and job titles within the programme
  - 1.2. A description of the responsibilities or remit of each role
  - 1.3. The number of staff currently employed in each role
  - 1.4. Whether roles are full-time, part-time, temporary, seconded, or permanent
  - 1.5. The pay band or grade for each role, if available
- 2. An organisational chart or visual structure (if one exists) showing how the Hwb programme is structured within the Welsh Government or Digital Services division, and how it relates to other relevant departments or directorates.
- 3. The total number of staff working on the Hwb programme, including any contractors or agency staff, as of the most recent date available.
- 4. A list of any external partners, agencies, or suppliers that are currently working with or contracted by the Hwb programme, along with a brief description of the nature of their involvement.

#### Our response

As the information you have requested involves detailed data and visual explanations, we have provided most of the information in the form of spreadsheets and diagrams as for clarity and completeness. These are set out in the attached annexes.

## A detailed breakdown of the current staffing structure of the Hwb programme

We have provided the necessary information to address your request for a detailed breakdown of the current staffing structure of the Hwb programme, including all individual roles and job titles, descriptions of each role's responsibilities, current staffing numbers, employment types (full-time, part-time, temporary, seconded, or permanent), and pay bands or grades where available. This information is set out in the organogram at **Annex A** and the accompanying spreadsheet at **Annex B**.

"The Act does not cover information that is in someone's head. If a member of the public asks for information, you only have to provide information you already have in recorded form. You do not have to create new information or find the answer to a question from staff who may happen to know it."
