The Programme Officer will be in contact with all objectors (regardless of whether their objection was later withdrawn) and the Saundersfoot Harbour Authority in due course to confirm the next procedural steps in relation to the inquiry including confirming a date for a pre-inquiry meeting with the Inquiry Chair. The purpose of the pre-inquiry meeting is for the Inquiry Chair to set out and agree the procedure for the inquiry.

The date and venue for the inquiry itself will be formally confirmed by the Programme Officer following the pre inquiry meeting. It is anticipated that the inquiry is likely to be scheduled to take place in late Autumn/ Winter 2025 although this is subject to formal confirmation and may change.
