ATISN 25041 - Letter from Cardiff & Vale University Health Board

Thank you for your request to Welsh Government for information under the Freedom of Information Act (2000) received on 07 August 2025 referring to a letter received from Cardiff & Vale University Health Board.

You have requested the following:

 All documents, communications, briefings, emails, meeting notes or other records relating to the letter sent by Cardiff & Vale University Health Board to the Chief Medical Officer and Chief Pharmaceutical Officer dated 14 August 2024.

Specifically:

- 1. Copies of any correspondence received by Welsh Government from Cardiff & Vale UHB relating to the above letter.
- 2. Copies of any internal Welsh Government discussions, emails, or briefings created as a result of receiving this letter.
- 3. Details of any actions taken, decisions made, or responses issued (including draft responses, if applicable).
- 4. Names of any officials or departments assigned to handle or analyse this concern.
- 5. Any records relating to Welsh Government's statement that it "did not hold" this letter (including internal justifications for this claim).

Our Response

- Welsh Government can confirm that it received a letter from Cardiff & Vale University Health Board on 14 August 2024 which is attached (Doc 1)
- Welsh Government can confirm that it holds information which fits the description of your request and correspondence documents are attached.

We have concluded that some of the information requested is exempt from disclosure under the following sections of the Freedom of Information Act:



• Section 40(2) – Personal Information of the Freedom of Information Act.

An explanation of our application of this exemption is set out at Annex 1 to this letter.

- Welsh Government does not hold any additional information that falls into scope of your request that has not already been provided.
- 4. Whilst we are unable to provide names of officials as they constitute personal data, the following directorates have considered the letter from Cardiff & Vale University Health Board:

- 5. In relation to your previous Freedom of Information request (ATISN 24629), you referred to a letter from Cardiff & Vale UHB in relation to The Kaleidoscope Project (TKP). As mentioned in our email to you on 02 June, we confirmed that Welsh Government did not hold a letter from Cardiff & Vale University Health Board which referred to The Kaleidoscope Project's (TKP) clinical involvement in Dyfodol not being registered as an independent clinic with HIW.

Freedom of Information Act 2000: Section 40(2) Personal information about others

Section 40(2) together with the conditions in section 40(3)(a)(i) or 40(3)(b) provides an absolute exemption if disclosure of the personal data would breach any of the data protection principles.

'Personal data' is defined in sections 3(2) and (3) of the Data Protection Act 1998 ('the DPA 2018') and means any information relating to an identified or identifiable living individual. An identifiable living individual is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of the individual.

We have concluded that, in this instance, the information caught by your request contains third party personal data.

Under Section 40(2) of the FOIA, personal data is exempt from release if disclosure would breach one of the data protection principles set out in Article 5 of the GDPR. We consider the principle being most relevant in this instance as being the first. This states that personal data must be:

"processed lawfully, fairly and in a transparent manner in relation to the data subject"

The lawful basis that is most relevant in relation to a request for information under the FOIA is Article 6(1)(f). This states:

"processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child".

In considering the application of Article 6(1)(f) in the context of a request for information under FOIA it is necessary to consider the following three-part test:

- **The Legitimate interest test**: Whether a legitimate interest is being pursued in the request for information.
- **The Necessity test**: Whether disclosure of the information/confirmation or denial that it is held is necessary to meet the legitimate interest in question.
- **The Balancing test**: Whether the above interests override the interests, fundamental rights and freedoms of the data subject.

Our consideration of these tests is set out below:

1. Legitimate interests

Your request includes emails which were caught by your request. I have not identified any legitimate interest that you may have in knowing the identities of those individuals named within the emails.

2. Is disclosure necessary?

We do not believe disclosure of the identities of those involved would allow any greater understanding of the content of the emails.

3. The balance between legitimate interests and the data subject's interests or fundamental rights and freedoms

As we do not believe disclosure of this personal data is necessary, there is no requirement on us to undertake a test to balance the legitimate interests against the right of individuals, as the fundamental rights and freedoms provided by the DPA are not being challenged.

I have concluded that there is a reasonable expectation that the identity of the living individuals named in the correspondence would not be made public. It is my view, therefore, that disclosure of the redacted information would breach the first data protection principle and thus is exempt from release under section 40 of the FOI Act.
