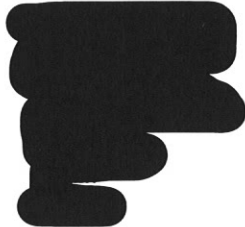

Welsh Government Energy Service – Grant Offer Letter

I am pleased to inform you that your application for grant assistance from the Welsh Government Energy Service, as set out in your application form of **16/03/2023**, has been approved.

- Scheme Conditions of Grant – Preparatory Funding

Unless otherwise stated, capitalised expressions used in this grant offer letter have the meanings given to those expressions in the conditions of grant referred to above.

Offer of Grant

The offer of grant is for a maximum of **£6,250.00** (six thousand, two hundred and fifty pounds) or **100%** of the Eligible Costs, whichever is the lesser amount.

For the purposes of this grant offer and the Scheme Conditions of Grant – Preparatory Funding, the "Eligible Costs" and "Payment Milestone" are/is as follows:-

- "Eligible Costs" means the fee payable by you, the recipients, for the costs of a National Grid project progression study and a geotechnical survey, as referred to in your application and further detailed in the "Special Conditions" below;
- "Payment Milestone" means the completion of the work as referred to above and submission of
Milestone 1: A copy of the National Grid progression study report (when available) and
Milestone 2: A copy of the Ground investigation and earthing study.

The grant offer set out in this letter is subject to the Scheme Conditions of Grant – Preparatory Funding enclosed with this letter and the "Special Conditions" set out in the following section of this letter.

Special Conditions

Unless otherwise expressly agreed in writing by the Energy Saving Trust, the scope of the legal support and tax advice to what the grant offer sets out in this letter must be consistent with what is envisaged in the quotes provided with your application.

To receive a grant payment before paying for the Eligible Costs, you must provide the Energy Saving Trust with the un-receipted invoice for the Eligible Costs from your supplier along with the grant claim form. You must then provide to the Energy Saving Trust within two weeks of receiving the grant payment the receipted invoice for the eligible costs from your supplier and a copy of a bank statement as evidence of the full payment of these invoices being made from your bank account to your supplier.

You must provide evidence of the legal advice work.

Claiming the Grant

In order to claim your grant, you will need to complete and sign the enclosed Scheme Grant Claim Form – Preparatory Funding. This form, together with all necessary supporting documentation, should be submitted either by electronic format or to the following address:
