Why are you receiving this letter?

We are writing to let you know that we have received an application from the Family Court. This is because you or someone in your family has made an application to the Court about children in your family, for example about who they live with or spend time with.

Usually, when the Family Court send an application to Cafcass Cymru, we will be asked to work with your family. The first step we take is to check with children's services and the police to see whether they are aware of any safety concerns. Sometimes, if your child has a Local Authority social worker, the Family Court might decide that it is better for children's services to do this work instead.

We will usually talk to all the adults involved in the case and often to the children. We may also talk to you about other agencies we would like to speak to or make enquiries with. Where safe to do so, we will try to help you and the other adults make safe arrangements that are in the children's best interests, and we will want to know what the children think and what will work well for them.

We will write a report for the Court summarising our work with you, this is called a Child Impact Report. The report will be filed with the Court and you and the other adult participants in the case will usually receive a copy. The Cafcass Cymru practitioner allocated to your case will explain more about the way we will work with you.
