NOTICE IS HEREBY GIVEN that the Welsh Ministers propose to hold public exhibitions of the draft Orders for the above scheme. Two public exhibitions of the draft Orders, associated plans and supporting documents will be held on 22 October 2025 at Ty Calon, Queensferry Campus, Chester Road West, Queensferry, Deeside, CH5 1SA from 10:00 am until 6:00 pm and on 29 October 2025 at the St Andrew's Church/St Andrew's Community Hub, Sealand Avenue, Garden City, Deeside, Flintshire CH5 2HN between 10:00 am and 6:00 pm.

Copies of the draft Orders together with their associated documents will be available for inspection at the Exhibitions.

Any persons who wish to have their views on the proposals considered should write to the Orders Branch, Transport, Welsh Government, Cathays Park, Cardiff CF10 3NQ or by email to TransportOrdersBranch@gov.wales quoting references qA2280938 and qA2282120 by 11 November 2025.

Please note: Should you wish to object, support or make representations in response to the draft Orders or comment on the Environmental Statement and/or the Statement to Inform an Appropriate Assessment, your correspondence will be considered by the project team and we may need to consult with people and organisations outside of the Welsh Government. As part of this process we may pass information to them, including information you have given us and your personal data. We will however, only disclose your personal details where it is necessary to do so to enable us to deal with the issues raised. Where a trunk road scheme becomes the subject of a Public Local Inquiry (PLI), all correspondence is copied to the Inspector of the Inquiry and is kept in the PLI Library and is publicly available. If you do not wish for certain personal data to be forwarded to third parties, you should state why when submitting your correspondence and the Welsh Ministers will copy the representations to the appropriate third parties with the name and address removed and if there is to be a PLI, the representations will be seen by the Inspector who may give them less weight as a result.
