What is a Single Unified Safeguarding Review?

A Single Unified Safeguarding Review (SUSR) is carried out when someone has experienced significant harm or has died, and where it is thought lessons can be learned.

Agencies will come together to discuss what happened and whether anything could have been done differently. You will be asked for your views on what happened. Your involvement is very important.

This provides an opportunity for agencies to consider what can be learned and what improvements can be made to practice and services in the future.

How do we do the Review?

A Review Panel made up of senior staff members from the agencies that worked with your family member is held to manage the review process.

The Panel may include staff from organisations such as the NHS, local authority, police service, education, probation or youth offending services, and any other agency who may have worked with your family member.

An independent Chair will be appointed to lead and oversee the Panel.

An independent Reviewer(s) will be appointed to review the practice and services that were provided to your family member and produce a Report with recommendations.

A separate Learning Event will be held and attended by staff who were directly involved with providing a service or support to your family member. It will allow them to reflect together on what happened and identify learning for future practice.

How do I contribute to the Review?

Your views are central to the SUSR process and are very important to us. Any views or feelings you want to share about what happened can be very helpful in producing the review.

If you are willing, the Chair or Reviewer(s) will contact you to determine how you would like to be involved in the Review. Additional support such as advocacy is available.

Some people have found the below questions helpful when considering what they want to share with the Reviewer(s):

- How do you feel about what happened?
- Is there something you wish had been done by the people working with your family member?
- Is there anything you wanted to be asked by the people working with your family member?
- Did you feel like you could talk to the people working with your family member?
- Is there anything you think could have been done differently?
- What would you like the Review to consider?

The Reviewer(s) will share your contributions with staff who attend the Learning Event so they can be reflected upon in any learning that is identified.

What happens next?

Multi-Agency Timeline

The Review Panel will produce a timeline of the contact agencies had with your family member. They will use this to understand what agencies knew about them and how they worked alone and together to support them. The timeline will also be considered at the learning event.

Engaging with Others

Your family member will be approached by the Reviewer(s) if they are well enough and it is deemed appropriate to do so.

The family of the person harmed by your family member will also be approached by the Reviewer(s) for their views.

Other people may also be approached to engage in the Review such as friends, community representatives/support services, neighbours, colleagues, faith and community leaders or employers.

Meeting the Panel

You will be given the option to meet with the Review Panel. This is your decision and you do not have to decide straight away. You can also change your mind during the Review process.

The Report

After the Learning Event the Reviewer(s) will write the SUSR Report using the information obtained from their engagement with all individuals spoken to through the process, the Panel and during the Learning Event.

The Report will provide recommendations on what needs to happen in the future.

Your views will be included in the Report.

You will be given the opportunity to view the draft Report to check it is accurate and to ensure your views have been captured appropriately.

The Report will not mention you or your family member by name.

The Report will be published and an Action Plan will be shared with the right people so that the actions can be addressed.



Your Feedback

At the end of the Review, you will also be provided with an opportunity to tell us your views on the Review process. For example:

- Is there anything you wish you had been asked about but weren't?
- Did you feel like you could talk openly to the people who were liaising with you?
- Is there anything that you think could have been done differently?
- Is there anything you think should have been done, but perhaps wasn't?

Your feedback is important to us and will inform how reviews are undertaken in the future.



Support Options

We understand that any incident which results in a SUSR will have been a traumatic and distressing experience. We would like to reassure you that support is available, whether you wish to engage with the Review process or not.
