**Notice under Section 1AA of the Ancient Monuments and Archaeological
Areas Act 1979
Prehistoric Rock Art 50m SW of Tai'r-waun-uchaf, Llanfabon (GM637)**

The Welsh Ministers have a duty to compile and maintain a schedule of monuments of national importance ("the Schedule") under section 1 of the Ancient Monuments and Archaeological Areas Act 1979 ("the 1979 Act"). The above named monument has been considered for inclusion in the schedule.

We are minded to include the monument in the schedule, and are consulting you for your views on the proposal under Section 1AA of the 1979 Act, as you have special knowledge of, or an interest in, the monument, or in monuments of special archaeological interest more generally.

The extent of the area that would be scheduled is marked in red on the attached maps. A copy of the site description provided by our Inspector of Ancient Monuments is also attached.

Whilst this consultation is underway, the proposed scheduled monument has interim protection in accordance with Section 1AB of the 1979 Act. This means that it is protected as if it were a scheduled monument from the date of this notice until you are notified that the Welsh Ministers have included the monument in the schedule.

I would be grateful if you can send any written representations you wish to make by 5 April 2023. If we do not hear from you by this date, we will assume that you do not wish to make any such representations.
