## ATISN 25194 - Flying Start

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 26 September 2025.

You requested the following:

- 1) How much money has each local authority received for the Flying Start programme in the 2024-25 financial year?
- 2) The total number of children currently registered on the Flying Start programme.
- 3) The number of Flying Start settings run by:
  - a) Local Authority
  - b) Third Sector
  - c) Private Sector.
- 4) The locations of Flying Start settings per local authority.

## **Our Response**

1. During FY 2024-25, the Children and Communities Grant awarded a total of £107.7 million<sup>(1)</sup> in revenue funding to Local Authorities to support the Flying Start programme.

During FY2024-25, the Childcare and Early Years Capital Programme awarded a total of £8.5 million to support sixteen major capital projects, all of which were Flying Start provisions. This funding supported a range of works including refurbishments, extensions, and the development of new standalone childcare settings.
