Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 09 October 2025.

You have requested the following:

 To clarify why the response to the FOIs ATISN 20821 & ATISN 20214 for COVID Wastewater Monitoring does not provide data for all 51 sites.

Response

Thank you for your enquiry regarding Wastewater Monitoring Programme data. We do not hold data for the sites you have identified as missing.

In August 2023 the Wastewater Monitoring Programme (then operating at 51 sites monitored) was paused due to considerable financial pressures on the Welsh Government budget. Officials worked closely with Bangor University and Cardiff University to understand how wastewater monitoring could add value to our integrated surveillance system at a revised scale.

In November 2023, this resulted in a reduced surveillance programme being utilised which continued monitoring at 11 sites across Wales.

We hope that this helps to explain the absence of data for the sites you identified.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it.
