Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 27 October 2025 regarding bad debts and overpayments.

- 2. Please break this down by category, including (where applicable):*
 - *Private patients*
 - *Overseas visitors*
 - *Supplier disputes*
 - *Staff overpayments*
 - *Other categories of write-offs recorded by the Health Board*
- 3. If available, please provide both the total number of individual write-offs and the total value for each category in each year.*
- 4. If the data is held in summary form (e.g. in finance reports or write-off schedules), please provide that document for each year.*
