The Bluetongue (Wales) Regulations 2008 (as amended) – Regulation 10(4) The Movement of Animals (Restrictions) (Wales) Order 2003 (as amended) - Article 5(7) The Bluetongue Regulations 2008 (as amended) – Regulation 13(2)

General licence for the movement of animals from within a Bluetongue Temporary Control Zone in Wales to a slaughterhouse in Wales or in England.

I, the undersigned, being a veterinary inspector appointed by the Welsh Ministers for the purposes of Bluetongue (Wales) Regulations 2008 (as amended) and the Movement of Animals (Restrictions) (Wales) Order 2003 (as amended) and by the Secretary of State for the purposes of the Bluetongue Regulations 2008 (as amended) [and the Movement of Animals (Restrictions) (England) Order 2002 (as amended) authorise, subject to the conditions set out in the Schedule below, the movement of animals from within a bluetongue Temporary Control Zone in Wales, to a slaughterhouse in Wales or in England.

Schedule of Conditions

Any person moving an animal under the authority of this licence must comply with the following conditions:

- 1. The movement of animals authorised by this licence shall be from a premises located within a bluetongue Temporary Control Zone in Wales direct to a slaughterhouse in Wales or in England.
- 2. No movement may take place under this licence if either the source premises or the destination premises are subject to a bluetongue premises restriction notice.
- 3. The licensee must accurately record the animal movements from the premises of origin to the destination premises on the relevant animal movement platform including the animal identification number.
- 4. Immediately prior to commencing the movement the licensee or their private veterinarian must inspect any animal to be moved under authority of this licence for clinical signs of bluetongue infection. If any animal inspected or other animal at the same premises displays signs that may be indicative of bluetongue infection, no animal may move from that premises under this licence. The animal displaying signs should be kept isolated from the rest of the herd/flock. You must report suspicion of bluetongue to APHA immediately.
- 5. The licensee must ensure that prior to loading animals, the requirements of condition 7 are complied with.
- 6. After unloading of animals, prior to the vehicle leaving the destination premises, the licensee must ensure the requirements of condition 7 are complied with.
- 7. The requirements referred to in condition 5 and 6 are:
 - a) The animal area of the vehicle is cleansed adequately ensuring it is free of organic matter that could attract midges prior to treatment in part b.
 - b) The animal area of the vehicle must have been treated with an insecticide in accordance with the label.
 - c) Any insecticide applied must be allowed to fully dry prior to loading any animals.
- 8. Subject to the conditions outlined in the Disease Control (Wales) Order 2003 (S.I. 2003/1966 (W.211) General Licence and the Disease Control (England) Order 2003 (S.I. 2003/1729) General Licence for the movement of cattle, sheep, goats and pigs', scheduled stops are permitted at the following locations:
 - a. Motorway service stations
 - b. Official lay-by (on a trunk/main road)
 - c. Lorry Park or similar place
- 9. The licensee must retain, for a minimum period of 2 years records of:
 - a. The number of animals moved under this licence.
 - b. The identification numbers of the animals moved under this licence,
 - c. Accurate destination premises of the animals moved.
 - d. Any insecticides used for the purpose of condition 8.
- 10. When moving anything under the authority of this licence, a person must carry with them a consignment note. The consignment note must include:
 - a. The species and number of animals being moved,
 - b. The date of the movement,

- c. The name of the consignor,
- d. The address of the premises from which the movement started (the sale or collection centre).
- e. The name and address of the consignee, and
- f. The name, address and CPH number of the premises of destination.
- 11. The move to the destination premises must be direct, by public highways, and by the route that is considered likely to be the quickest available.
- 12. No pick-ups or drop-offs at other premises are permitted.
- 13. All movements are subject to the animal being properly identified in compliance with the current livestock identification regulations for the species and accompanied by the appropriate duly completed movement documentation. Movements must comply with routine movement standstill and reporting requirements.

Notes

- 1. "The Regulations" means the Bluetongue (Wales) Regulations 2008 (as amended) (<u>S.I. 2008/1090</u>) (<u>W. 116</u>) or the Bluetongue Regulations 2008 (as amended)
- "The Order" means the Movement of Animals (Restrictions) (Wales) Order 2003 (as amended) (S.I. 2003/399) (W. 56) or the Movement of Animals (Restrictions) (England) Order 2002 (S.I. 2002/3229)
- 3. "Animal" means a ruminating animal or camelid. Ruminating animals include but are not limited to cattle, sheep, goats, deer. Camelids include but are not limited to llamas and alpacas.
- A "bluetongue Temporary Control Zone" means a temporary control zone declared under regulation 10(1) of the Bluetongue (Wales) Regulations 2008 (as amended) (S.I. 2008/1090 (W.116) and a temporary control area declared under Article 5(1) of Movement of Animals (Restrictions) (Wales) Order 2003 (as amended) (S.I. 2003/399) (W. 56).
- 5. "Licensee" means person moving animals under this licence.
- 6. This licence does not override any other existing movement restrictions on animals under other legislation.
- 7. Animals which meet the conditions of this licence are exempt from the requirement of a premovement test prior to leaving a bluetongue Temporary Control Zone to a final destination to a slaughterhouse in Wales or in England.
- 8. The requirements set out in this licence do not affect the user's obligations under The Transport of Animals (Cleansing and Disinfection) (Wales) (No. 3) Order 2003 (as amended) (S.I. 2003/1968 (W.213)) or the Transport of Animals (Cleansing and Disinfection) (England) (No. 3) Order 2003 (as amended) (S.I. 2003/1724) to cleanse and disinfect the vehicle.
- 9. All requirements of the Disease Control (Wales) Order 2003 (as amended) (S.I. 2003/1966 (W.211)) or the Disease Control (England) Order 2003 (as amended) (S.I. 2003/1729) and licences under those Orders must be met.
- 10. A person moving anything under the authority of this licence must, if asked to do so by a veterinary inspector, an inspector, or other officer of the Welsh Ministers or the Secretary of State give their name and address, produce the consignment note and allow copies or an extract to be taken.
- 11. The insecticide applied to vehicles used to transport animals moved under the authority of this licence must be effective against flying insects, ideally Culicoides (midges), and applied as per the manufacturer's instructions. It should ideally contain the active ingredients: pyrethrin or synthetic pyrethroids. Ideally, they should be used in a spray format and be suitable for use indoors. It must be currently authorised by the Health and Safety Executive (HSE) as a biocidal product for use in the UK.
 - The licensee should check and adhere to the manufacturer's instructions for the conditions of use of any products applied to the vehicles used to transport animals being moved under the authority of this licence.
- 12. If you suspect notifiable disease in England, you must report this immediately to Defra Rural Services Helpline on 03000 200 301. If you suspect notifiable disease in Wales, you must report this immediately to the Animal and Plant Health Agency (the APHA) on 03003 038 268.
- 13. All other relevant legislation must be complied with.

14. Contact DEFRA Rural Services Helpline in England or the APHA in Wales on the number provided above or your Local Authority (LA) for further advice on biosecurity measures and any other legislation that may apply.

Any person who contravenes any requirement or prohibition of a declaration made under the Regulations shall be committing an offence and may be liable on summary conviction to a level 5 fine on the standard scale or to imprisonment for a term not exceeding three months or both (by virtue of regulation 25 of the Regulations)

Any person who contravenes any requirement or prohibition of a declaration made under the Order shall be guilty of an offence and may be liable on summary conviction to imprisonment for a term not exceeding six months or to a fine not exceeding level 5 on the standard scale or to both (by virtue of section 72 of the Animal Health Act 1981)
