Notes

- This movement document meets the reporting requirements of:
 - the Sheep and Goats (Records, Identification and Movement) (Wales) Order 2015 (SAGRIMO); and
 - Article 4 of Council Regulation (EC) No.1/2005 on the welfare of animals during transport and related operations which requires transporters to carry documentation, referred to in the United Kingdom as an Animal Transport Certificate, recording the origin and ownership of the animals, place of departure and arrival and certain information allowing journey times to be checked and assessed.
- All fields on the movement document must be completed to comply with paragraph 1 above.
- It is the CPH of the premises from which the animals are departing, and to which they are travelling, that must be recorded on the form. The address must accurately reflect where the animals are moving from and travelling to.
- This document serves as a **single** movement reporting document. Each stage of a multiple move must be completed on a separate movement reporting document.
- Where Section 1 has not been completed by the departure keeper, it must **not** be completed by the keeper at the arrival holding. EIDCymru and/or Local Authorities will contact the departure keeper for that information.
- Vet Attestation Number (section 3) – enter this 20 digit number (provided to you by your vet after an animal health visit). Without it meat and products from the animals might not be eligible for export, see example below.
