
### About us

#### **Direct award**

If there is only one supplier on an agreement, you can place a direct award. This is also possible on some agreements with multiple suppliers.

### **Further competition**

If you're using an agreement with multiple suppliers, you will get the best value by asking suppliers to bid based on your individual needs. It allows you to tailor the requirement, as long as it is within the original scope of the framework.

### Dynamic purchasing systems

With our dynamic purchasing systems, you can search online using a range of criteria, to shortlist suitable suppliers. You can then invite them to bid against your detailed specification.






