## Request for Information - ATISN 26240

I wrote to you on 13 October regarding your request for information.

## Information requested:

You have asked for all record information which relates to works, temporary possession, occupation of land, or use of private property on or adjacent to the A5 at Glyndyfrdwy Denbighshire between 2008 and 2010. Specifically, you have requested:

- Site inspections reports, site diaries, site photos, and engineer/inspector notes
- Records of any temporary occupation or use of private property including possession notices, site records, site photos before, during and after possession of land, Detailed plans of works carried out on private land adjacent to A5.
- Correspondence and emails between the Welsh Government, trunk road project teams, contractors, and Denbighshire County Council that relate to the works at Glyndyfrdwy.
- Contractor reports, method statements, environmental risk assessments, and traffic management plans for works on the A5 at Glyndyfrdwy and the adjacent private property used as a works site.
- Records of any complaints, enforcement actions. or internal investigations relating to the works at Glyndyfrdwy.

I also suggested ways that would help you to specify or narrow your request for information. As you have not written further in this regard, on this occasion I have decided to refuse your request for information as it will cost more than the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to answer your request. The reasons for refusing your request were quoted in the letter sent to you dated 13 October 2025.
