**Request for Information - ATISN 26261**

Thank you for your request for information which I received on 16 October 2025.

You have asked for:

- List of junctions / slip roads on the A55 which have been closed and the duration for the last two financial years.

**Our response**

The Welsh Government holds the information you requested.

In the table below, the significant majority of the closures were for programmed cyclic maintenance works where the slip roads are sequentially closed for short periods of time between the hours of 19:00 and 06:00. It is not possible to provide individual durations of closures.

Financial Year	Number of Closures	Day	Night
2023/2024	322	8 (2%)	314 (98%)
2024/2025	459	8 (2%)	451 (98%)
<b>Total =</b>	<b>771</b>	<b>16 (2%)</b>	<b>765 (98%)</b>

There were also 5 emergency closures in 23/24 and 13 in 24/25.
