Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 24 November 2025 relating to the use of data and technology in the clinical laboratory. You requested the following:

- How many of each tests are done?
- What are the costs and broken down if possible?
- What is the cost for comparative reflex requisitioned tests versus repeating venepunctures?
- How much reflex testing does each laboratory do?
- On Wales gov., 30% of primary care expenditure was on GMS for 23, it would be beneficial to obtain more data on the spending breakdown.
- Also, you are interested in 'chronic disease management' or 'non-communicable disease' and would like a breakdown of DES/ LES/ QUAFF/ QUAIFF performance driven payments.
