Welsh Government has funded the organisation Community Energy Wales or Ynni Teg, these constitute the titles. The purpose of our funding to Community Energy Wales and Ynni Teg are detailed in ATISN 25085 in annex 1.

- Summary of outputs achieved or reported

Outlined in ATISN 25085 at annex 3 is a summary of monitoring which is also evidenced how we collect evidence of outputs for Community Energy Wales. For Ynni Teg, the funding is very tangible and relates to physical installation of energy infrastructure, so the evidence is completion of the project as outlined in the grant award letters.

Welsh Government has provided copies of evaluation reports where they are available. We shared the evaluation of funding to CEW from the foundation economy funding in ATISN 25184. There are no further evaluation reports.
