The Minister will wish to be aware, independent Chair of Merthyr Tydfil CBC's Improvement and Assurance Board, called earlier to let us know that he received a call from a BBC Wales correspondent yesterday regarding Councillor Kevin O'Neill alleging he has been suspended as Leader for a period of seven months.

Wasn't aware and he has since spoken to interim Chief Executive of the Council, who also had not heard anything on the matter.
