Dear Emma Reynolds MP,

I congratulate you on your appointment as Pensions Minister and look forward to working with you.

I very much welcomed your meeting with representatives from the Women Against State Pension Inequality (WASPI) campaign group in September. This was a very significant and positive step forward for those women born in the 1950s who had their state pension age raised without effective or sufficient notification.

Your willingness to meet with WASPI was received very favourably and clearly demonstrates a more positive and constructive approach to resolving this issue. However, there is no single group which represents the millions of women affected by this issue. I urge you to look at ways of engaging with other campaign groups, beyond WASPI. I am sure that such engagement would be welcomed and assist you in your work towards bringing this longstanding issue to a just, fair and satisfactory resolution at the earliest opportunity.

I have heard first-hand the negative impacts suffered by this cohort of women, not only financially but how it has impacted their physical and mental health. These effects will have been exacerbated by both the pandemic and the cost-of-living crisis and it is, therefore, even more important that any wrongs are put right as soon as possible.

This is a complex issue and I appreciate that not all women were impacted equally. However, this is no longer an issue of whether this cohort of women experienced unfair treatment. The conclusions of the Parliamentary and Health Service Ombudsman's (PHSO) investigation were clear and unequivocal in this respect - maladministration by the Department for Work and Pensions (DWP) caused injustice.

The challenge is now about finding a remedy. Justice must be done and seen to be done. I know you are currently giving the PHSO's report careful consideration. The Prime Minister recently indicated that the Secretary of State for Work and Pensions will soon be making a statement on this issue. This is very welcome news. I trust the statement will set out the process and timeline for implementing the PHSO's recommendations. Addressing this issue is not only a matter of financial justice but also a moral responsibility.

I am sure you will continue to give this matter the attention it deserves in order to find a way forward, not only for the women directly affected but also for the wider trust in our public institutions and to demonstrate the accountability of Government.
