ATISN 26525 – Enforcement Notice Appeals by the former Secretary of State

Thank you for your request submitted on 20 December 2025, which I received on the 22 December 2025.

Your request asks for:

- In 1990 the Secretary of State issued decisions on enforcement appeals, relating to the Funship site at Llanerchymor, Nr Holywell, CH89DX.
- Copies of any decision letters, determinations, or records issued by the Secretary of State for Wales in relation to these enforcement appeals.
- Copies of any correspondence or records relating to the award of costs against Delyn Borough Council arising from these appeal decisions.
- Any transferred or inherited records held by the Welsh Government following devolution that originate from the Wales Office or Secretary of State for Wales concerning these appeals.

If no such records are held, confirmation of whether the Welsh Government believes these records were:

- transferred to The National Archives,
- destroyed in accordance with a records retention schedule, or
- retained by another public body.

Response

The information you have requested is not held by the Welsh Government. The Welsh Government's retention period for holding records is 10 years. However, the information may have been transferred to the National Archives in either Aberystwyth or Kew. You can seek the information at:

Please note you may need to register prior to searching the sites and charges may be incurred in receiving copies of any information, if held.

Responsibility for maintenance of the public planning register, however, lies with Local Planning Authorities in the first instance. This includes the decision notice relating to any planning or enforcement appeal for an application within an Authority's area. In this case, Flintshire County Council succeeded Delyn Borough

Council in 1996 and inherited this responsibility. The Council should be able to produce a copy of the relevant appeal decisions.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:

Data Protection

The request you sent me contains personal information about you - for example, your name and e-mail address.
