### **Final Police Settlement 2026-27**

This letter is to inform you of the Welsh Government's component of the Final Police Settlement for police forces in Wales for 2026-27, subject to approval by Senedd Cymru.

The Home Office has confirmed that all Welsh police forces will receive an increase of 4.022% in core funding in 2026-27.

**Annex A** contains details of the Final Settlement for each police force in Wales. The Welsh Government's contribution of £113.47m remains unchanged from the Provisional Police Settlement.

While I recognise the pressures on policing services and the rising costs they face, I must also remain mindful of the ongoing cost-of-living challenges experienced by many households. The overall increase in the Police Settlement exceeds the Office for Budget Responsibility's forecast for CPI inflation of 2.5% in 2026. I therefore encourage you to ensure that any proposed precept increases take this into account and remain manageable for households already under considerable financial strain.

The Local Government Finance Report (No.2) 2026-27 (Final Settlement – Police and Crime Commissioners) published today is scheduled for debate in the Senedd on 3 March 2026.

#### Notes:

1. Following the 2015 Comprehensive Spending Review, the Home Office made an annual transfer of funding to the Welsh Government in order for the Welsh Government to deliver its agreed contribution to police funding in Wales. From 2022-23 onwards, this additional funding is no longer transferred and is instead delivered by the Home Office via the Police Grant and Top Up Grant. This resulted in the Welsh Government contribution to policing reducing by £29.93m in 2022-23 and subsequent years. This is purely an administrative change and does not result in any change in overall funding for any police force.

2. This is the amount of police grant set out in Section 3 of the Police Grant Report which includes the allocation under 'Principal Formula' and 'Add Rule 1' (columns a and b) plus the amount of 'floor funding' that the Home Office has made available.

3. Figures have been adjusted to account for Special Branch funding.

4. Figures are shown including the 'Additional Rule 2' funding.

5. Figures for 2023-24 have been restated to include the in-year funding awarded to forces for the 2023-24 pay deal.
