I wrote to you on 2 February regarding your request for information.

Your Request

You asked for:

1. Copies of (or links to) any licenses, permits, agreements, or permissions Welsh Government (or its agents) has applied for, issued, considered, or commented on in relation to Gilestone Farm (Gilestone Farm, Talybont-on-Usk, Brecon, Powys, LD3 7JE) from 1 January 2021 to date;
2. Copies of any 'Habitat Regulations Assessment' and/or 'Appropriate Assessments' undertaken in relation to Gilestone Farm from 1 January 2021 to date; and
3. Excluding information provided under 1 and 2 above, provide copies of any communications (internal and external) in relation to 'Habitat Regulations Assessment' and/or 'Appropriate Assessments' in relation to Gilestone Farm.
