ATISN 25047 – Request for information about children's homes in Wales.

Thank you for your request which we received on 10/08/2025.

You asked for the following information:

- 1. *The number of placements of individual children that have been made with children's services providers Operating Without Registration (OWR) across all 22 Welsh Local Authorities since June 2024. Broken down month-by-month and by local authority, covering all OWR placements since June 2024.***
 - *Of these placements, further broken down by how many attributable to Local Authority providers, private providers, and voluntary providers.***
- 2. *The number of new children's homes registrations since June 2024 across all 22 Welsh Local Authorities. Broken down month-by-month and by Local Authority and by who has registered the provision (Local Authority, private provider, voluntary provider).***
 - *Of these new registrations, confirmation of how many are brand new children's homes operators (have not previously been OWR), and how many are services which were previously OWR and have since become registered***
- 3. *Confirmation of CIW enforcement action in relation to children's homes across all 22 Welsh Local Authorities, including closures since June 2024. Broken down month-by-month and by Local Authority and provider type (Local Authority, private provider, voluntary provider).***
- 4. *The percentage of staff working within Local Authority children's homes which are agency members of staff and not permanent employees, across all 22 Welsh Local Authorities since January 2022. Broken down month-by-month and by Local Authority.***

Our response

We have considered your request under the Freedom of Information Act 2000. The information you requested held by CIW is attached as follows.

- 1. *The number of placements of individual children that have been made with children's services providers Operating Without Registration (OWR) across all 22 Welsh Local Authorities since June 2024. Broken down month-by-month and by local authority, covering all OWR placements since June 2024.***
 - *Of these placements, further broken down by how many attributable to Local Authority providers, private providers, and voluntary providers.***

We responded to a previous request from The Children's Homes Association for this information on 03/01/2025, reference ATISN 22136. In that response we explained we are unable to provide the exact data requested. The data we hold is not about individual placements of children, but of occurrences of care homes for children operating without registration (OWR) in Wales. We have therefore provided this same data from 01/06/2024 to 10/08/2025 at **Annex 1 Table 1** attached. This is broken down by provider type i.e. operated by a local authority or a private company.

This data is therefore not representative of the actual number of children who have been placed in a care home for children operating without registration. We do not have unique identifiers for each child and are therefore unable to account for how many children were in each of the care homes operating without registration. To confirm, the data provided is therefore the number of occurrences of a care home for children operating without registration, rather than the number of placements of individual children.

We must ensure any information we disclose could not inadvertently identify any individual people to which that data relates, particular vulnerable children. This means we are unable to provide a breakdown of this data on a month-by-month basis because where the numbers are low, there is a risk of individual children being identified from that data when this is put into the public domain. We have therefore provided the totals for the date range requested, however where the number of children for any individual local authority is less than 5, we have not given the specific figure but recorded it is less than 5 (<5). The overall total number of occurrences is included.

2. The number of new children's homes registrations since June 2024 across all 22 Welsh Local Authorities. Broken down month-by-month and by Local Authority and by who has registered the provision (Local Authority, private provider, voluntary provider).

- **Of these new registrations, confirmation of how many are brand new children's homes operators (have not previously been OWR), and how many are services which were previously OWR and have since become registered**

Data on new children's homes registered from 01/06/2024 to 10/08/2025 by local authority and provider type is enclosed at **Annex 1, Table 2**. This is further broken-down by month of registration at **Table 2a**.

Please note, we have interpreted 'new' children's homes to mean any new registrations of children's homes where the premises was not previously registered as a children's home. The data does not therefore include new registrations of existing children's homes that re-registered under a new provider.

We have included on **Table 2** the number of newly registered services that were registered subsequent to them operating without registration.

3. Confirmation of CIW enforcement action in relation to children's homes across all 22 Welsh Local Authorities, including closures since June 2024. Broken down month-by-month and by Local Authority and provider type (Local Authority, private provider, voluntary provider).

Our approach to taking enforcement action is set out in our [Securing Improvement and Enforcement Policy](#). Actions we may take to support providers to improve include issuing Priority Action Notices where failings are identified. If we do not see improvement following this, we may then take statutory enforcement action e.g. cancelling a provider's registration.

Data on Priority Action Notices issued in respect of children's homes from 01/06/2024 to 10/08/2025 by local authority and provider type is enclosed at **Annex 1, Table 3**. This is further broken-down by month of issue at **Table 3a**.

Data on any care homes for children closed under its enforcement powers between 01/06/2024 and 10/08/2025 is enclosed at **Annex 1, Table 3b**.

4. The percentage of staff working within Local Authority children's homes which are agency members of staff and not permanent employees, across all 22 Welsh Local Authorities since January 2022. Broken down month-by-month and by Local Authority.

The only data we hold about staff working in children's homes is from the Annual Returns submitted to us by service providers. Data from the 2024 Annual Returns is available on our online data tool here: [Adults and Children's Services Data Tool](#).

You can find the data on agency staff for Local Authority children's homes as follows:

- Select the '**Workforce – Care Homes Services**' tab
- Go to the filter option, scroll down to the '**Service Type and Subtype**' filter option and select '**Care Home Service – Children's Home**'. Then go to the '**Service Provider Type and Subtype**' option and select '**Local Authority**'
- Scroll down to the '**Contractual Arrangements**' data where you will find the number of agency or bank staff for each role.

This data represents the self-reported information submitted by service providers as of census day 31 March 2024. We do not hold data on how many agency staff were employed over the period specified, only as at this annual collection date.

Data collected within the 2023 Annual Return is no longer available as the data has been replaced with the data collected within the 2024 Annual Return. However, we provided the link to that data within our response to the previous request from the Children's Homes Association on 03/01/2025.

Data collected within the 2025 Annual Return is currently being prepared for publication within the online data tool later this year. The data requested for 2025 is therefore exempt from disclosure under **Section 22(1) 'Information intended for future publication'** of the Freedom of Information Act. Our reasons for applying this exemption are set out at **Annex 1** to this response.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.

Annex 1

Application of exemptions

The Freedom of information Act provide a right for anyone to ask a public authority to make requested information available to the wider public. As the release of requested information is to the world, not just the requester, public authorities need to consider the effects of making the information freely available to everybody. Any personal interest the requester has for accessing the information cannot override those wider considerations.

We have decided to withhold the following information:

Information being withheld	Section number and exemption name
Data on agency staff working within Local Authority children's homes which are agency members of staff across all 22 Welsh Local Authorities collected by CIW within the 2025 Annual Returns.	Section 22(1) of the Freedom of Information Act - 'Information intended for future publication'

Section 22: Information intended for future publication

Section 22(1) of the Freedom of Information Act (FoIA) states:

- (1) Information is exempt information if -*
- (a) the information is held by the public authority with a view to its publication, by the authority or any other person, at some future date (whether determined or not),*
 - (b) the information was already held with a view to such publication at the time when the request for information was made, and*
 - (c) it is reasonable in all the circumstances that the information should be withheld from disclosure until the date referred to in paragraph (a).*

We believe it is reasonable this information is withheld from disclosure until it's intended publication later this year to allow time for the data to be collated from the individual Annual Returns, analysed and then checked prior to publication.

Public Interest Test

We do not believe any public interest in earlier disclosure of this data would outweigh the interest in withholding it as this data is scheduled for publication in the very near future and it forms only a small part of the overall data that will be published. The resource needed for CIW to separately collate and provide this part of the data early would not be in the public interest.

We therefore consider Section 22(1) is engaged and the data is withheld.
