Thank-you so much for your swift reply. Yes - could we meet on site on Tuesday March 17th at, say, 11am?

In the meantime any comments you may have on the draft brief would be much appreciated. The brief as it stands is taken from the standard Natural England brief for historic parkland management plans.

Registered boundary: I was not aware that there had been proposed changes to the Registered boundary - and it would be good to look at this when we meet. There are parts of this boundary - for example the walled garden near Buckland Farm - which my client does not own, and again, we can discuss when we meet. I think it would be helpful to send out a new formal consultation letter given the change in ownership - which only occurred in January this year. I have been given your name by garden historian [Regulation 13 Personal Data](cc'd). She is the owner of [Regulation 13 Personal Data] and has recently restored [Regulation 13 Personal Data]. She and I have recently been appointed to work at [Regulation 13 Personal Data]. Buckland Hall and its Registered Park and Garden was bought last month by our client with the intention to restore it as a family home and to restore the park, garden and wider landscape. I am Director of [Regulation 13 Personal Data], a practice that specialises in the restoration and repair of historic landscapes.
