ATISN 26596: The design, conduct, and administration of the Glyndŵr (North East Wales) National Park consultation

Information requested

Thank you for your request which I received on 21 January. You asked for:

Information concerning the design, conduct and administration of the Glyndŵr National Park statutory consultation held by Natural Resources Wales (NRW) between Monday, 15 September and Monday, 8 December 2025. In particular, how the consultation was instructed, managed, and processed, including decisions about public participation, response treatment, and anonymity. Specifically, you are requesting:

1. Instructions or Guidance (instructions, briefing notes, formal communications, or internal memoranda between January 2022 and now concerning the objectives, scope or methodology of the consultation)
2. Aims and Purpose (documents describing whether the consultation's purpose was to determine if a national park should be created, or how one should be implemented – including reference to commitments contained in the Welsh Government's (WG) manifesto)
3. Governance and Oversight (correspondence between WG and NRW outlining decision-making authority, reporting arrangements or approval processes during the consultation period)
4. Consultation Design and Response Handling instructions or guidance regarding:
 - How responses were to be gathered, recorded and analysed;
 - The format for registering support or objection;
 - Criteria for accepting or rejecting submissions, including the 1,015 signed letters that were excluded from analysis.
5. Anonymity and Data Protection (guidance, instructions or correspondence regarding whether the consultation process was intended to be anonymous, including:
 - Policies or statements on how respondents' personal information should be handled
 - Any communications or decisions leading to the rejection or redaction of responses containing such information
 - Copies of any Data Protection Impact Assessments, internal legal advice or data-handling policies used in this context
6. Equality and Accessibility (Any Equality Impact Assessments, internal equalities analyses, or accessibility guidance provided to ensure compliance with the **Public Sector Equality Duty (Section 149, Equality Act 2010)** and inclusion of disabled or digitally-excluded participants)
7. Stakeholder Engagement (Copies of any correspondence or briefing materials listing which statutory and community stakeholders (including Police, Fire and Rescue, Health Board, and Ambulance Service) were invited or expected to contribute to the consultation).

1.	3 February 2022	Procedural Guidance - Statutory Landscape Designation DRAFT 3 Feb 2022	<p>Statutory and Public Consultation</p> <p>Before any formal Designation Order is made, the relevant legislation specifically requires that for National Parks, all county councils, National Park Authorities and community councils, that have land within the area to be designated, or in the existing National Park or to be varied, must be consulted prior to a Designation Order being made. For AONBs, only 'Principal Council' Local Authorities must be consulted. NRW is legally required only to undertake a statutory consultation. As a matter of good practice NRW will also seek engagement with key stakeholders and the public.</p> <p>Statutory and public consultation responses may present new evidence to justify the inclusion or exclusion of land, identify further considerations as to the desirability of designation, or identify specific boundary issues which need review. Following any statutory or public consultation, responses must be catalogued and detailed qualitative and quantitative analysis is carried out. A Consultation Analysis Report is to be prepared and published, giving NRW's responses to all the issues raised, and recording its decisions in relation to objections and requests to amend the proposals.</p> <p>If persuaded by the evidence supplied in consultation responses, NRW may take a decision to update its evidence, and on this basis review the assessments to produce a revised proposal. The consultation analysis document thus forms a key part of the evidence base, as it records judgements and decisions which are likely to be tested if there is a public inquiry. NRW will need to rely on the detail in its responses to the issues raised, so high quality, detailed reporting is required.</p> <p>The relevant stages in the process of evaluating land for designation set out above may therefore need to be repeated, as part of an iterative process. For example if, as a result of new evidence supplied, additional areas of land are brought into the proposed designation, a further round of statutory consultation would be required.</p>

3.	14 June 2023	NRW briefing note for Local Authorities	Stage 3 – Statutory designation process. Following the consultation, all responses and any amendments to the boundary will be considered before presenting a recommendation to Welsh Government. If there is sufficient evidence to demonstrate that the statutory

		– June 2023	criteria relating to natural beauty and opportunities for open-air recreation are met, and that the area is of such national significance that National Park purposes should apply, a Designation Order will be submitted to Welsh Government. Ministers will then consider this and decide whether to confirm, refuse or vary the Designation Order. If confirmed, Welsh Government will establish a new National Park in North East Wales.
4.	16 October 2024	Cabinet Secretary for Transport and North Wales - Senedd Questions - Lines and background on new NP designation - for SQs on 16 October 2024	NRW has completed the mapping of the initial Area of Search and first engagement phase. The engagement was designed to identify the range of views, positive and negative, ahead of the statutory consultation phase with relevant local authorities in September and October 2025, to help this proceed as smoothly as possible.

As previously mentioned, the consultation will be on the basis of a National Park, using the latest, amended boundary, and using the name 'Parc Cenedlaethol Glyndŵr'. The statutory consultees are the affected Local Authorities and (following legal advice) the CJs.
