## **ATISN 26624 – Health and Care Pay 2025/2026**

Thank you for your request to Welsh Government for information under the Freedom of Information Act (2000) received on 28 January 2026

You referred to your previous FOI request ATISN 25143 which was completed on 8<sup>th</sup> October 2025. We confirmed that the Cabinet Secretary for Health and Social Services had not yet confirmed the pay award for those in the NHS on Executive and Senior terms and conditions - this would be considered in the context of the wider position on public sector pay and announced in due course. We also confirmed that a 3.25% 2025/26 pay award for Senior Civil Servants in Welsh Government was to be implemented in October and back dated to 1st April 2025. In relation to this you have asked for the following:

- 1a. Provide details of the pay award that NHS managers (ESP/VSM) who are not paid under Agenda for Change terms or Medical and Dental Terms have been awarded in 2025/26.*
- 1b. Confirm if this pay award has been implemented and if not when this is expected.*
- 2. If a pay award for Executive and Senior Managers in the NHS has not been made, provide WG decision reports that set out the reasons for this cohort of staff not receiving a pay award.*
- 3. If a pay award for Executive and Senior Managers in the NHS has not been made, please confirm the number of individuals affected by this decision. Noting that you have previously confirmed that all other NHS staff in Wales (agenda for change and medical and dental staff), as well as senior civil servants in the Health, Social Care and Early Years department of Welsh Government, have received inflationary pay uplifts in 2025/26.*
- 4. If a pay award for Executive and Senior Managers in the NHS has not been made, confirm the salaries for the highest pay point within agenda for change pay scales (based on 2025/26 uplifted pay) and the lowest pay point within ESP/VSM pay (based on 2025/26 pay which has not received uplift).*
