Request for Information - ATISN 26887

Thank you for your request for information which I received on 14 April. Your request has been logged under reference ATISN 26887. You have asked for the following information relating to military aircraft use of Cardiff Airport:

1. how many US military aircraft have used Cardiff Wales Airport, ideally on a monthly basis, from April 2024 to date (14 April 2026);
2. is there a blanket agreement that the US military can use Cardiff Wales Airport, or does the US military have to apply for permission to use Cardiff Wales Airport whenever it wants to use the airport;
3. whether any other countries' military aircraft have agreements to use Cardiff Wales Airport..
