ATISN 26958 – Welsh Government grant funding

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 07 May 2026 relating to the planning application A26023 that is currently being processed by Ceredigion County Council.

You referred to the proposal comprising of the provision of a Care facility off Maes y Dderwen Cardigan [96 rooms] adjacent to the Integrated Health Centre, and residential development at land off Bath House Road Cardigan [70 apartments + 27 houses]. The proposed development is on separate parcels of land as outlined.

You requested the following:

- *I would be grateful if you could provide - from Welsh Government records - brief details of Welsh Government grant funding allocated for these proposed projects.*

Response

Following searches undertaken by Welsh Government, no funding has been provided through the Health capital, Integration and Rebalancing Capital Fund or the Housing with Care Funds.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. Your personal information will then be disposed of securely.

- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
